



DECISION OF ANTI-RAGGING COMMITTEE REGARDING RAGGING IN HOSTEL.

The Anti-Ragging Committee received reports of Senior students (2nd & 3rd year) ragging Junior students (1st year) in Pettigrew Hostel, Old Campus, Patkai Christian College. This was also reported by the Anti-Ragging Cell of UGC, the report of which they received through email on their portal. The committee conducted an enquiry and concluded that the report was true. After intense deliberations, and based on the gravity of the situation, the committee decided upon the following course of action:

1. All those senior students involved in ragging junior students will be expelled from hostel with immediate effect. They shall not be allowed hostel admission in future.
2. They shall be suspended from attending lectures for one week.
3. All the other 2nd and 3rd year hostellers of Pettigrew, the hostel in which ragging took place, will do community service for 2 Saturdays of 2 hours duration, for remaining silent during the incident.
