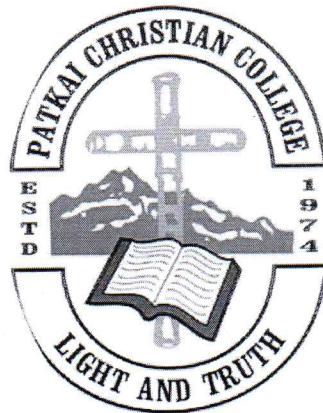
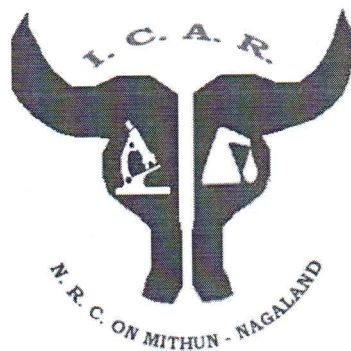

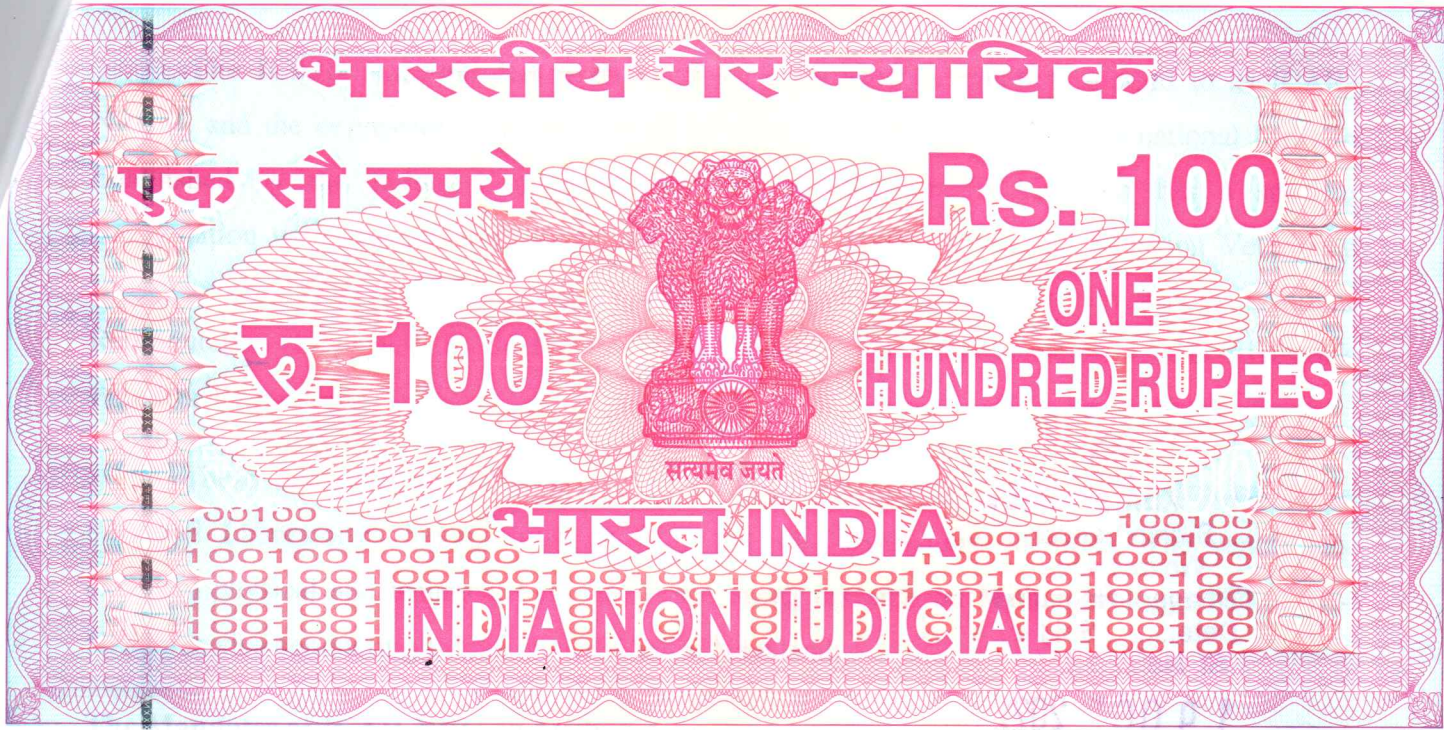

Agricultural Research (ICAR), having its registered office at Krishi Bhavan, New Delhi- 110001
(hereinafter, referred to as ICAR-NRCM). Through its authorized representative, the Director as
first party.

PREAMBLE:

Patkai Christian College (Autonomous) was established in 1974 as a liberal Arts
College. Today, the College is a multidisciplinary institution of higher education offering courses
in Arts, Science, Commerce and Music with 15 academic departments at the undergraduate and 7
postgraduate departments.

The ICAR- National Research Centre on Mithun (hereinafter referred to as ICAR-NRCM, and the expression shall include all its present and future Units) is a national Institute established by the Indian Council of Agricultural Research (ICAR) and has a specific staff/position with specialization in Animal Genetics & Breeding, Animal Nutrition Veterinary Microbiology, Veterinary Medicine, Veterinary Pathology, Veterinary Physiology, Animal Reproduction, Livestock Production & Management, Veterinary Extension and Livestock Products Technology.

These Scientists are well trained in their field in India/abroad. The centre has well-equipped Laboratories having most modern scientific instruments/facilities. The centre has excellent physical and technical laboratories for doing research on Mithun biology. The ICAR-NRCM is also conducting extension activities in Nagaland.

The Mandates of ICAR-NRC on Mithun are:


1. Identification, evaluation and characterization of Mithun germplasm available in the country
2. Conservation and improvement of Mithun for meat and milk
3. To act as repository of information on Mithun

Both, ICAR-NRC on Mithun, Medziphema Nagaland and Patkai Christian College, Chumukedima, Nagaland shares a common desire to explore, extend and strengthen the functional scientific relationship. In order to share the facilities and expertise available in each other Institute herewith sign a Memorandum of Understanding. Considering these factors and mutual interest, Patkai Christian College, Chumukedima and ICAR-NRC on Mithun Medziphema extended hand for collaborative efforts with each under MoU.

Understanding the scope of collaborative participation in various programmes to be mutually agreeable in future, **ICAR-NRCM** and Patkai Christian College, Chumukedima, Nagaland, sign this Memorandum of Understanding (MoU) for jointly undertaking various programmes of mutual interest with the following terms and conditions and agree to carry out their respective responsibility as detailed in the MoU.

ARTICLE I

The Parties, hereby, agree to promote the development of cooperation with their responsibilities as under:

- 1.1 Any Scientist of NRCM fulfilling the qualifications/requirement as such for a Guide/Co-Guide/ Co-Adviser of Advisory committee of Master/M. Phil/Ph.D students as prescribed by Patkai Christian College can act as the Member of Advisory Committee.
- 1.2 The Research, Library & Extension facilities available at both the places, i.e. Patkai Christian College and ICAR-NRCM would be utilized on a bilateral basis.
- 1.3 The help rendered by the ICAR-NRCM will be properly acknowledged in the thesis and any publication/award/patent emerging out of the joint research work in collaboration with ICAR-NRCM will be jointly shared.
- 1.4 The joint research conducted at ICAR-NRCM under this MoU would be the joint property of ICAR-NRCM and Patkai Christian College.
- 1.5 If the concerned students received any fellowship and contingencies during the dissertation, the scholar may need to spend from the research contingencies towards the expenses meeting the consumables, if so required.
- 1.6 The student would invariably be the senior author for the publications arising out of the joint research work conducted and followed by Major Guide/Advisor/Co-Guide (Thesis Research Guide) in that order. The names of the additional co-authors, depending upon their contribution in the research work, may be decided by mutual consent between the student and Major Guide/Advisor.
- 1.7 In all publications arising from the Thesis Research Work (TRW)/Dissertation Research Work (DRW), a mention will always be there that ICAR-NRCM, Medziphema, Nagaland is the place of work. Affiliation of the authors from the University, however, may appear as the name of the place from where they belong.
- 1.8 The student has to submit a copy of the Master/M. Phil/Ph.D thesis also to the library of ICAR-NRCM, Medziphema.
- 1.9 The help rendered by ICAR-NRCM and its personnel would be duly acknowledged in the thesis and Publications by the concerned student.

1.10 The accommodation will be provided to the students at ICAR-NRC on Mithun subjected to availability. However, cost of accommodation and other expenses (electric bill, food etc.) have to be borne by the students.

1.11 Guidelines for the students to conduct research for their degree programme will be based on the guideline provided by the ICAR-New Delhi, F.No.2-8/2012-HRD, dated 11th December, 2012 (enclosed Annexure I). As and when the ICAR amends the guidelines, same will be applicable for this collaboration.

ARTICLE-II

Patkai Christian College, Chumukedima and the ICAR-NRCM, Medziphema, may name any member of their staff to develop suitable work plan in collaborative areas.

ARTICLE-III

Intellectual property research publication and benefits arising out of commercialization of technologies generated out of co-operation under this agreement shall be jointly owned/shared by Patkai Christian College and NRCM for its development.

ARTICLE-IV

A joint-follow up committee will be set up with representatives from both parties to meet periodically to follow up the execution of this MoU and suggest necessary measures for its development.

ARTICLE- V

The parties of this MoU may, be mutual consent, add, modify, amend or delete any word, phrase, sentence, or article in this MoU at any time during the operation of MoU.

ARTICLE- VI


The MoU shall be effective from the date of its signing by both the parties and shall remain in operation for five (05) years or until either party serves notice on the other of its intention to terminate it, in which event, the MoU shall stand terminated at the end of one calendar month from the date of issue of such a notice.

ARTICLE- VII

Both the parties will try to create/develop a new experimental and research/training facilities through mutual cooperation and in exchange of experts.

ARTICLE-VIII

The parties would act strictly according to the relevant provisions of law while implementing this MoU. In case of any dispute that may crop up during execution of MoU the matter would be settled through arbitration by referring it to a committee jointly appointed by both parties.

ARTICLE-IX

Any types of expenditure incurred through the joint programmes held together under this MoU will be borne as per mutual agreements which will be made on case to case.

ARTICLE-IX

Periodical meeting of student's Advisory Committee can either be conducted through video conferencing or if conducted in person than expenditure towards TA/DA will be borne with mutual consultation of both the parties and with the availability of funds.

ARTICLE-XI

Any dispute arising out of the agreement shall be settled by mutual negotiation between two parties.







3.2 SPECIFIC

Based upon student's parent institution, the guidelines may be categorised into two heads as under:

3.2. 1. Within National Agricultural Research System (AU/DU to ICAR Institute)

A. Advisor/Guide

- (i) The criterion for allocation of Major Guide/Advisor will primarily be governed by the intellectual input and time duration devoted for carrying out the research work at a particular institution. It may be decided by mutual consent, keeping in view the MOU signed between partnering institutions. If the major guide is from ICAR Institute, the co-guide will be from partnering university and vice-versa.
- (ii) The ICAR scientists pursuing their PhD degrees after completing their PhD course work at ICAR-DUs may be allowed to do their research work at the institute where they are posted, in view of shortage of scientists/faculty.

B. Fee Structure

If a student registered with AU/DU intends to carry out the research work at ICAR Institute, latter may not charge any fee from the registering institution/student, except the hostel accommodation charges, etc. However, if a student registers with AU/DU after qualifying through competitive mode of ICAR's All India Entrance Examination for Admission to Master's/PhD and is awarded fellowship for pursuing Master's or Doctoral degree programme by any sponsoring institution [e.g. ICAR-JRF(PGS)/ICAR-SRF(PGS)/CSIR-UGC-JRF/CSIR-SRF], the contingency grant awarded to the student may be transferred to the institution where major part of the research work would be carried out and regulated by the provisions contained in the guidelines of sponsoring institution.

C. Publications

- (i) The student would invariably be the senior author for the publications arising out of the research work conducted at the AU/DU/Institutes, followed by Major Guide/Advisor and Co-Major Advisor/Co-Guide in that order. The names of additional co-authors, depending upon their contribution in the research work, may be decided by mutual consent between the student and Major Guide/Advisor.
- (ii) The partnering institutions may ensure that the institute should ensure that the student submits atleast one paper from Master's thesis and two papers from Ph.D. thesis before thesis submission in order to prevent students leaving the institute(s) without any research publication from the thesis.

E-WASTE MANAGEMENT AGREEMENT

The Agreement is entered into at Kolkata on this 4th day of April, 2025

By and Between

Hulladek Recycling Private Limited, a company incorporated under the Companies Act 2013 having its registered office at 4, D.L. Khan Road, Flat No. B-401, 4th Floor, Kolkata-700025, West Bengal, India hereinafter referred to as First Party which expression shall unless contrary to and or repugnant to the context mean and include its successors representative and permitted assigns through Mr. Nandan Mall (Director) to enter into and sign this Agreement for and on behalf of the First Party.


Patkai Christian College, an Educational Institution located at Seithekama, Chumoukedima – 797103, NAGALAND, hereinafter referred to as Second Party which expression shall unless contrary to and or repugnant to the context mean and include its successors representative and permitted assigns through the Dr. Thepfulvie Pieru, Principal to enter into and sign this Agreement for and on behalf of the Second Party.


Whereas,

A) First Party is a registered Producer Responsibility Organization (PRO) vide The Registration No. B-29016(12)/ (PRO)/18/WM-III Division dated 12.11.2024 valid up to 12.11.2029 and is authorized to undertake activities prescribed for Producer Responsibility Organizations.

e-CIRCLE, a registered E-waste Collection Center vide NPCB/E-waste 1/1141 dated 13-08-2024 till 13-08-2029 having its registered office at House No. 93, C-Khel, Diphupar, Chumoukedima, Nagaland, will act as the First Party's partner for collection and storage of E-waste in Nagaland.





B) The Second Party in compliance of E-Waste (Management & Handling) Rules, 2016 and its Amendments, desires to have services for management of their Electronic Waste except liquid waste

This Agreement sets for the terms and understanding between the First Party and the Second Part that:

1. The First Party has agreed to pick up, transport, carry the E-Waste through its channel partner **e-CIRCLE** and recycle/dispose it off from the Second Party as per the norms prescribed by the Government Authorities from time to time.
2. The First Party has agreed to make available the Utilization Certificate confirming that E-Waste provided by the Second party to the First Party has been recycled/ disposed of as per the norms prescribed by the Government Authorities within 60 days of the pick up of the E-Waste.
3. The Second Party will sign required documents to acknowledge that E-Waste has been handed over to the First Party.
4. The First party shall install "E-waste Collection Bin" at or any other location as may be prescribed by the second party.
5. The First Party shall from time to time conduct IEC activities on E-waste Management and the Second Party shall conduct E-waste collection drives (at least once per year).
6. The Second party shall pay a management fee of Rs. 6000 /- per annum to the First Party to be paid in advance.
7. The Second Party will accumulate all E-Waste in the "E-waste Collection Bin" provided by the First Party or in a separate room and inform the First Party once reasonable volume has accumulated. The pickups confirmed by the Second Party will be carried out on a priority basis,
8. The Second Party's responsibility will cease once electronic waste has been handed over to the First Party as per clause 3 above. Thereafter, no liability would accrue to the Second party on account of e-waste.
9. This agreement will be in force for a period of 2 years from 4/4/2025 to 4/4/2027 from the date of execution of this Agreement and can be renewed at the end of every period by mutual consent.
10. Records & data of the e-waste material procured will be maintained and transparently shared by the First Party.
11. The Second Party has agreed that the general waste such as Municipal Solid Waste will not be included in the E-Waste.
12. It is clearly agreed that all the E-waste procured by or in the possession of the Second Party will be exclusively managed by the first party as per the terms and conditions specified above.
13. Either party can terminate this Agreement by giving 90 days written notice in advance to the other party citing reasonable grounds for such action. However, the other party is not entitled to claim any compensation for such premature termination if with reasonable sufficient grounds.
