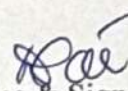
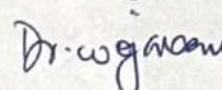

Proceedings and Resolutions

The Board undertook a review of the proposed Philosophy syllabi for Semesters I–VIII under the Four-Year Undergraduate Programme (FYUP), in accordance with the National Education Policy (NEP) 2020.

The meeting commenced with a review of the syllabi for Semesters I–VI. The Board examined the course objectives, content structure, and overall organisation of the courses. After detailed deliberation, the syllabi for Semesters I–VI were unanimously approved without modification.

The Board thereafter proceeded to a detailed review of the proposed syllabi for Semesters VII and VIII. Following thorough examination the Board approved the syllabi with the following recommendations:

1. Major 17

The Board recommended that Unit II be replaced with the following:

- Quine's Refutation of the Analytic-Synthetic Distinction
- H. P. Grice and P. F. Strawson's Defence of the Analytic-Synthetic Distinction

The Board further recommended that Unit V be replaced with Austin's Theory of Speech Acts, covering the following:

- i. Locutionary Act
- ii. Illocutionary Act
- iii. Perlocutionary Act

2. Major 18 and Major 20

The Board noted that Major 18 – Continental Philosophy was placed in Semester VII, while Major 20 – Existentialism was placed in Semester VIII.

After deliberation, the Board recommended that Major 18 and Major 20 be placed in the same semester, i.e., Semester VII.

3. Major 19

The Board recommended the addition of Unit V, with the topic:

Indian Theories of Meaning

4. Major 22 – Philosophical Counselling

The Board recommended the addition of two more units to Major 22 – Philosophical Counselling.

5. Major 23

The Board recommended the inclusion of the terms "Indian and Western" in the title of the course.
